This poses a fire hazard to consumers.</p> <p><b>INCIDENTS/INJURIES</b></p> <p>GE has received five reports of fires, four of which caused minor damage to the kitchen countertops where the dishwashers were installed and one caused minor damage to adjacent cabinets and smoke damage to the home.
